In consideration of Bison Motor Company extending credit hereunder, the undersigned jointly and severally and unconditionally guarantee and promise to pay Bison Motor Company on demand, any and all indebtedness of the above named applicant to Bison Motor Company. This is a continuing guarantee, and the obligations created hereby are unaffected by any change in the terms of the original indebtedness between Bison Motor Company and above named applicant save that of payment.
